The inspection was over a limited period of time and it was not possible to observe all procedures and practices associated with your food business.

During the course of the inspection, the premises on this occasion were found to comply with the above-mentioned legislation and it was found that good food hygiene and food standards practices were in operation. Where applicable I have enclosed several observations and recommendations for your assistance.

The food hygiene inspection report is attached. Schedule A details contraventions of food safety and food standards law at the time of inspection which require your attention. Schedule B details recommendations, which provide advice on good practice.

Schedule A has been divided into three sections representing the three areas you are scored against for the Food Hygiene Rating Scheme and a section detailing Other Legal Matters.

Details of how your score in each section relates to your overall hygiene rating are included in the schedule so that you can see what factors have influenced your rating.

Enclosed is your Food Hygiene Rating sticker which must be displayed in a conspicuous place at or near each entrance to your food business.

Previously issued stickers and certificates should be destroyed. Failure to display a current sticker is an offence and carries a fixed £200 fine and/or prosecution.

Whilst it is appreciated that you have a rating of 5, for information, the scheme allows for appeals and re-visits for the purpose of re-rating for ratings below 5. Details regarding this are provided below.

If you consider the hygiene rating is unjust you may contact Adrian Watson. If following discussions, you still feel the score is unjust, you may appeal in writing within 21 days to Mrs H O'Loughlin, Team Leader, Food Safety and Food Standards.

If you have addressed all the non-compliances raised in the inspection report and can evidence these, then you can apply for a re-visit for the purposes of re-rating. The charge for a re-score visit is £180 which must be paid on application.

Other Legal Matters

Food Hygiene Rating (Promotion of Food Hygiene Rating) (Wales) Regulations 2016

As discussed during the inspection, since November 2016 takeaways in Wales are required to include a bilingual statement on leaflets or flyers such as takeaway menus telling consumers where they may find details of the food hygiene rating on the website of the FSA. The following wording must be used:

"Ewch i food.gov.uk/ratings i ganfod sgôr hylendid bwyd ein busnes neu gofynnwch inni beth yw ein sgôr hylendid bwyd wrth archebu./ Go to food.gov.uk/ratings to find out the food hygiene rating of our business, or ask us for our food hygiene rating when you order."

This wording must be positioned in a conspicuous place on any hard copy material that shows food for sale, the price and a way of ordering the food without visiting the premises. The minimum size of font should be 9 pt and in 'Times New Roman' font with a gap between text lines of least 3 mm.
